Who is the online training for?

The online training is aimed at everyone who has to do with the FSC-CoC-certification or aims to do so in the future. It is therefore relevant for companies that are already certified and those who would like to be in the future. The training is also valuable for actors outside the CoC system such as forest managers who want to know more about the chain of custody.

What does the training include?

A total of 9 modules on the most important topics in the CoC certification system. The most important aspects include an Introduction to the FSC certification, an overview of the universal requirements for certification and how FSC claims can be controlled and monitored. The training also offers examples and practical advice on topics such as sourcing reclaimed materials. After successful completion of the quiz at the end of the training, you will receive a certificate.








You can access the training under "Go to course catalog"

After paying the course fee the course will be listed under "My Courses"


